

BOARD OF REVIEW

MAY 19, 2009

The Board of Review for the Town of Hiles was called to order on Tuesday, May 19, 2009 at 6:50 p.m. Present were: Doris Lovrine, Larry Berg, Marilyn Pfeiffer and Cathy Votis. Roll call: Lovrine & Berg supervisors, clerk Votis and Treasurer McKay-Burkey. Agenda read. Motion to accept Lovrine. Second Berg. Vote all aye. Minutes read. Motion to accept Lovrine. Second Berg. Pfeiffer stated that the roads inspection took place on May 6th instead of April 22nd due to snow. Treasurer's report was read. **OFFICER & COMMITTEE REPORTS:** Judy asked that the cemetery sign be taken down and brought to her so that she can redo it. Also will look into grant money for road signs and fire numbers. Clerk will see if Lange can give the board an idea on the cost of replacing the road signs. Transfer Station hours were discussed and it was decided to open on Saturdays from 8am to noon and leave Wed and Sundays at 10am-2pm. Custodians will be talked to about this. Pfeiffer stated that the first meeting with the comprehensive plan committee went very well and they will be meeting again on May 27th. The annual roads inspection was discussed. Pfeiffer will contact Fahrner Asphalt about crack seal.

The need to hire a new town hall custodian was discussed. An ad will be placed in the paper with deadline for June 12, 2009. Lovrine asked if the town has a road limits ordinance. It was agreed by the board that one does need to be developed and passed. **BARTENDERS**
