A quote for a new outside sign was presented to the board. The cost for a larger one would be \$30,000 and smaller sign \$28,000. A motion to approve the purchase of the sign made by Duhn, motion seconded by Bukovic. Motion carried.

Debris clean-up

A local logger would bring a Ponsse through to clean up the sides of the roads. It would around \$200 per hour. It would be one or two days. A motion was made by Bukovic to hire Chad McCrea to do the roadway clean-up, motion seconded by Bruno. Motion carried

Officer and Committee Reports

Bukovic: Get new electronic door locks for North Fire Department. Will order them. Old Jaws of Life being given to North Fire Department. Construction on the Mill Pond dam. A construction company gave an estimate to do pilings for the dam. Will review next month. Looking to purchase a bench and a sit and spin for the playground. Lights are installed at the veterans memorial. Get rock around flag poles.
